The audit should cover the following:

- ✓ The entire systems of accounting and internal control,
- ✓ Donor contractual agreements, compliance with statutory returns among others
- ✓ Human resource and operational aspects/control environment

In addition to the financial audit, the audit firm will assist TNS in filing its income tax return and any related appendices as provided by the applicable laws and regulations.

The auditor is expected to produce the following deliverables;

1. The Annual statutory audit report containing the auditor's independent opinion on the financial statements
2. The Management letter spelling out each audit finding, the risk it poses to the organization, the appropriate auditor's recommendation and the management's response. Each finding should be properly categorized as 'High Risk', 'Medium Risk' or 'Low Risk'.
3. Filing Technoserve Rwanda income tax return and any related appendices as provided by the applicable laws and regulations.
